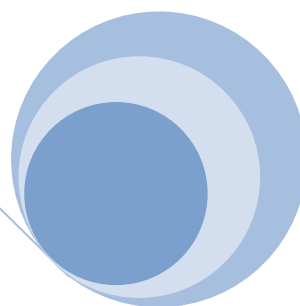
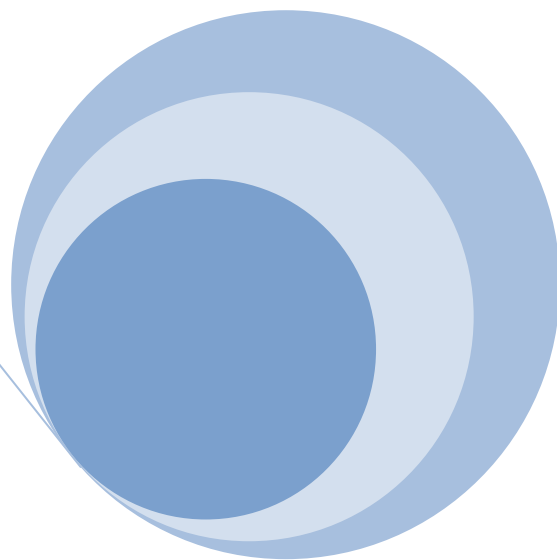
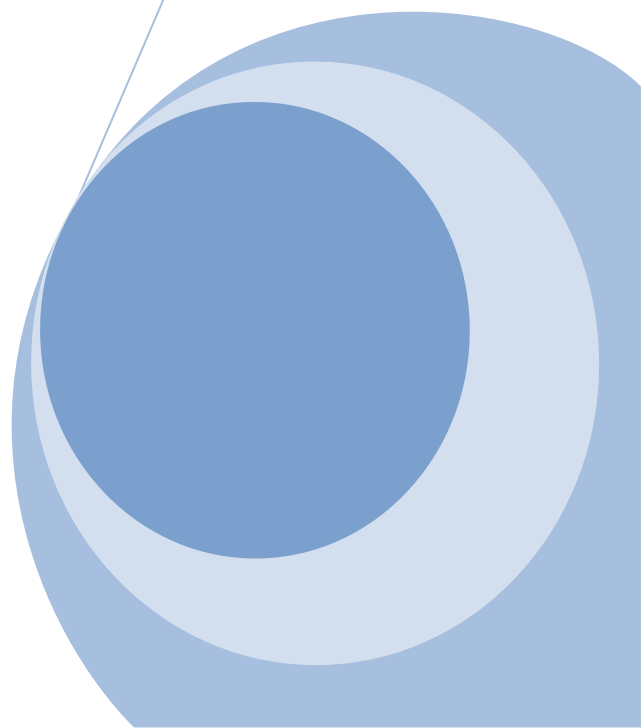

## 1. TESTNO OKRUŽENJE

Ovaj testni paket predstavlja skup testnih scenarija, koji se mogu izvoditi u testnom okruženju HRAIS faze testiranja 1.0 i to putem XML poruka. Testni paket služi kao pomoć proizvođačima i dobavljačima softverskih aplikacija za carinske sustave otpremnika, kako bi im omogućio i olakšao testiranje najvažnijih poruka kojima gospodarstvenici u okviru vanjske domene komuniciraju sa sustavom HRAIS-a.

Testno okruženje za testiranje HRAIS aplikacija nalazi se u sklopu G2B servisa koje pruža Carinska uprava. Osnovna namjena G2B servisa je razmjena elektroničkih dokumenta između IS CURH i informacijskih sustava gospodarstvenika. Taj servis tehnološki je realiziran kao web servis (SOAP/HTTPS) i koristi internet kao komunikacijski kanal. Tehnička specifikacija G2B servisa nalazi se u istoimenom dokumentu, dok su su specifičnosti G2B servisa koje su vezane uz HRAIS aplikaciju opisane u dokumentu *'Tehnička specifikacija G2B servisa za HRAIS'*.

Osnovni preduvjeti koje proizvođači softverskih aplikacija moraju osigurati za testiranje HRAIS aplikacije prije nego krenu u postupak registracije carinskih G2B usluga:

- osigurati digitalne certifikate kod FINA-e na način opisan u dokumentu 'Opće G2B upute za korisnike'. Na web stranicama Carinske uprave [www.carina.hr](http://www.carina.hr), u dijelu rezerviranom za e-carinu, nalazi se sva navedena dokumentacija te su dostupne detaljne upute o svim carinskim G2B uslugama;
- ishoditi EORI broj ([http://www.carina.hr/e\\_carina/EORI.aspx](http://www.carina.hr/e_carina/EORI.aspx))
- prijaviti se za testiranje HRAIS aplikacije (unutar e-Carine).

Prijavom za testiranje HRAIS aplikacije, generirat će se i korisnički podaci za pristup sustavu za praćenje testiranja.

Preporuča se da proizvođači softverskih aplikacija uspješno prođu testiranje svih 13 testnih scenarija iz faze 1. testiranja, prije nego počnu testirati aplikaciju u sljedećoj fazi.

Testnom okruženju za testiranje vlastitih HRAIS aplikacija proizvođači softverskih aplikacija pristupaju na način opisan u tim dokumentima.

Za uvođenje HRAIS faze 1 u carinski sustav Republike Hrvatske nadležan je projektni tim koji se sastoji od poslovnog i IT dijela i njegov zadatak je, između ostalog, priprema i održavanje dokumentacije za vanjske korisnike.

Za sva pitanja i nejasnoće vezano uz implementaciju HRAIS sustava, te za prijavu problema u radu testnog okruženja NAIA aplikacije ili njene nedostupnosti nadležan je HRAIS tim Carinske uprave, pri kojem korisnici mogu dobiti odgovore na upite stručne i tehničke prirode. Kontakt:

## 2. SCENARIJI ZA RAZMJENU ELEKTRONIČKIH PORUKA

Testni scenariji koji su dio ovog dokumenta pokrivaju funkcionalnosti HRAIS-a faze 1.0.

Svih 13 scenarija odnosi se na tip A (redovne) deklaracije, te carinski postupak puštanja robe u slobodan promet (40 00).

U sljedećim fazama testiranja bit će omogućeno testiranje ostalih tipova deklaracija, te ostali carinski postupci.

Ova verzija dokumenta '*HRAIS Testni scenariji za gospodarstvenike*' sadrži testne scenarije koji obuhvaćaju poruke koje se razmjenjuju između gospodarstvenika i Carine u okviru HRAIS sustava – IE415, IE407, IE413, IE414, IE420, IE416, IE406, IE404, IE405, IE409+/-, IE423, IE428, IE429, IE460, IE461, IE449, IE450, IE451 i DM401.

Testni scenarij TSC12 trenutno nije moguće testirati, a Carinska uprava obavijestit će gospodarstvenike kada će testiranje istog biti dostupno. U testnom scenariju TSC12 omogućit će razmjena sljedećih IE poruka: IE430, IE490 i IE431.
